



InReach 2023 Junior Board Membership Dues Requirement

Membership dues requirement for the 2023 Tri-State Chapter & Virtual Chapter (launching in January 2023)

Standard membership rate:

Members of the 2023 Tri-State and Virtual Chapters may choose from the following two payment options in order to fulfill (or exceed) the annual \$1,000 membership dues requirement:

Payment Option #1: 2 Payments of \$500 (First Upfront & Second in 6 Months)

1. **First payment of \$500** due before your chapter's first annual meeting to confirm your spot on the Junior Board (**no later than January 31st, 2023**)
2. **Remaining \$500** due in 6 months (**no later than June 30th, 2023**)

Payment Option #2: 10 Payments of \$100 per Month (January - October)

1. Monthly payments of \$100 for 10 months (first **payment due by January 27th, 2023, additional monthly payments due no later than the 30th of each month**)

***Adjusted membership rate for members joining throughout the year:**

All members joining the Tri-State and Virtual Chapters after January 2023 will have their membership dues prorated for their 2023 term of service according to the following schedule:

- Join date February 2023: Dues \$900
 - Choice between 9 payments of \$100 (Feb - Oct 2023) OR 2 payments of \$450 (first payment due by end of Feb & second payment due by the end of July 2023)
- Join date March 2023: Dues \$800
 - Choice between 8 payments of \$100 (March - Oct 2023) OR 2 payments of \$400 (first payment due by end of March & second payment due by the end of Sept 2023)
- Join date April 2023: Dues \$700
 - Choice between 7 payments of \$100 (April - Oct 2023) or 2 payments of \$350 (first payment due by end of April & second payment due by the end of Oct 2023)

- Join date June 2023: Dues \$600
 - Choice between 6 payments of \$100 (June - Nov 2023) or 2 payments of \$250 (first payment due by end of June & second payment due by the end of Nov 2023)
 - Join date July 2023: Dues \$500
 - Choice between 5 payments of \$100 (June - Oct 2023) or 2 payments of \$250 (first payment due by end of July & second payment due by the end of Dec 2023)

Membership dues requirement for the 2023 Great Lakes Chapter, National Capital Chapter & West Coast Chapter (launching in July 2023)

Members of the 2023 Great Lakes, National Capital and West Coast Chapters (launching in July 2023) will pay prorated annual membership fees (**\$500 for 2023**).

Members may choose from the following two payment options in order to fulfill (or exceed) the prorated \$500 annual membership dues requirement for their chapter:

Payment Option #1: 2 Payments of \$250 (First Upfront & Second in 6 Months)

1. **First payment of \$250** due before your chapter's first annual meeting to confirm your spot on the Junior Board (**no later than July 31st, 2023**)
2. **Remaining \$250** due in 6 months (**no later than December 31st, 2023**)

Payment Option #2: 5 Payments of \$100 per Month (July - November)

1. Monthly payments of \$100 for first 5 months (first payment due by July 28th, 2023, **additional monthly payments due no later than the 30th of each month**)
